2024	Beverly Bell (Contra Costa)	For her assistance with the silent auction at the Annual Conference since 2015. Her tireless efforts contribute to the success of the auctions with proceeds used to offset future conference registration fees.
2024	Monterey Chapter	For their invaluable service resulting in a very successful annual conference in Monterey. They secured a nationally-known keynote speaker resulting in record attendance at the annual conference.
2024	Rob Vlieger (Santa Barbara)	Provided invaluable accounting insights and financial assistance to the Santa Barbara County Civil Grand Jury for fifteen years. Rob's commitment in facilitating the jury's operational needs have been pivotal to the grand jury's success.
2023	Anatolia "Toli" Lubos (San Francisco)	For years of service to the San Francisco Civil Grand Jury managing all aspects of the jury including recruitment, interviewing prospective jurors, arranging training, updating juror handbook, logging citizen complaints. 2022	Rob Warren (1968-2021) (Alameda)	In recognition of his strong support of the mission of civil grand juries to ensure that civic agencies worked in the best interests of the public. During his tenure the Alameda County Civil Grand Jury issued 86 reports one of which received CGJA's Excellence in Reporting Award in 2019. Rob successfully encouraged former jurors to establish the Alameda County Civil grand Jury Association. It was formed in 2016 as an affiliate chapter of CGJA. His tireless efforts to promote good governance in Alameda County will be missed.
2022	Shirley Boracci (Glenn)	In recognition of her multiple terms on the Glenn County Grand Jury, once as Foreperson and currently as Secretary. Along with a fellow juror Shirley took on the task of updating and correcting the Glenn County Procedures Manual, which was approved by County Counsel, printed and distributed. Shirley organized the Glenn County Alumni Association Chapter and currently serves as its President. She is currently serving as a CGJA Director for the Northern Region and serves on numerous CGJA Committees.

2019	Andi Winters (Shasta)	In recognition of her exemplary service in support of the grand jury system. Andi served 3 terms as a CGJA Director and ably led the Association as its President from 2016 to 2018. Andi is a past member of the San Francisco chapter and of the El Dorado County Grand Jurors' Association. 2019	Doug Gillen (Orange)	In recognition of his exemplary work improving recruitment efforts for the Orange County grand jury. He was a member of them 2016-17 and 2018-19 Orange County Grand Jury. Mr. Gillen developed, drafted and designed a tri-fold brochure with basic and practical information about the grand jury. This brochure was approved by the presiding Judge and is available in the petit jury meeting room.

She is a former Director, former Assistant Treasurer, former Treasurer, current Membership Database Manager, and a recently retired long-time grand jury trainer. 2019	Judi Lazenby (Santa Cruz)	In recognition of her exemplary service in support of the grand jury system. Judi was a director for 6 years and skillfully served as president from 2006 to 2008. Judi also served as Treasurer for 2 years and was a CGJA trainer for 14 years. She is currently a member of the Program Administration Subcommittee. Judi also contributes many hours to her local CGJA Chapter in Santa Cruz County. Neither organization would be where it is today without her contributions.
2018	Leslie Lea (Contra Costa)	In recognition of her exemplary service in support of the grand jury system, the CGJA, the Contra Costa chapter of the CGJA and her role as the travel agent for the CGJA Training Committee.
2018	2016-2017 Contra Costa Grand Jury	In recognition of their hard work and tenacity in discovering and exposing the misuse of campaign funds of an elected official. As a result of the filing of an accusation, the District Attorney pleaded no-contest to one count of perjury and his license to practice law was revoked by the California Supreme Court.
