# **Director Candidate Statements**

### **South Region**

#### Henry Rible (San Luis Obispo)

I am currently a member of CGJA's board of directors for the south region of California, having been appointed to fill the board seat after the previous occupant resigned prior to the expiration of the term. I am now seeking a full two-year term as director. I am active on the Membership and Chapter Relations committee, as well as the Public Relations Committee.

## July Chapter Presidents' (and Others) Meeting by Barbara Sommer, Editor

Plan on attending the annual conference in October and let us know beforehand about your activities for expanding grand jury awareness and how you have been working with the courts. Be on the panels!

These words from CGJA President, Lou Panetta, opened the July 20, 2022, online meeting of chapter and association officers and members. Representatives from twelve chapters and one association (Orange) met with Panetta and Membership and Chapter Relations Committee (MCRC) chair, Diane Lloyd, to discuss issues relevant to their concerns.

Training Committee chair, Marsha Caranci, updated participants on this year's training. "Everybody's back in business." The trainers are very busy, and the program is going well.

Lloyd (MCRC) outlined an incentive program, perhaps involving subsidized memberships, to get more chapter members to join CGJA and participate in the activities of the association. The subsequent discussion yielded very helpful suggestions from chapter representatives. Further developments will be unveiled soon.

The next topic dealt with financial support from the county superior court for grand jury outreach efforts. Shasta County has a memorandum of understanding with the court that allows them to bill for recruitment activities. See **Shasta County Chapter-Court Personal Services** listed under **Juror Recruitment**.

There was general agreement that court personnel have more money than time to spend on grand jury recruitment. Thus, there might be a willingness in other counties for the courts to similarly subsidize chapter involvement. A panel at the annual conference in October will explore this issue further, along with other aspects of the chapter-court relationship.

During the open discussion at the end of the meeting Al Witten described intensified implementation efforts by the Placer County Grand Jury (*more on continuity in the next issue of the Journal – ed.*).

Juliana Jones, chair of the Public Relations Committee (PRC), said that the committee is preparing a modifiable template for chapter use promoting grand jury month. It will be sent to chapter/association presidents in advance of February.

She also requested that chapter Facebook pages be linked to that of the CGJA by a "like." In turn, CGJA will "like" yours with a hopeful result of increased readership. An article in the June 2022 CGJA Journal provides more detail (see page 7).

Panetta pointed out that we need volunteers who understand social media, and the Membership and Chapter Relations Committee needs more members.

The Chapter Officers' meetings have been held every 3 months. However, we will not meet in October and instead, hope to see all of you in-person at the annual conference for a vibrant exchange of ideas.

# **Excellence in Reporting Award Nominations**

This year we received three nominations for CGJA's **Best Grand Jury Report** award and one for the **Best News Media Coverage** award. The four-member Excellence in Reporting Subcommittee of the CGJA Awards Committee is reviewing them.

See the **award criteria**. The winners will be introduced at the **annual conference** in San Rafael on October 23, 2022.

#### **BEST GRAND JURY REPORT**

#### SACRAMENTO

#### (2020-21) *Del Paso Manor Water Dist. (DPMWD) Flooded with Public Safety Dangers* (2021-22) *Sacramento County Grand Jury Status Review: Del Paso Manor Water District*

The report tells the cautionary tale of a small and troubled special district with a storyline that could readily apply to other special districts whose failings have not yet come to public awareness. It spotlights the "we are not legally required to assist" mentality of some elected leaders and heads of local and state agencies. The investigative report, agency responses, and subsequent April 2022 status review expose a deficiency in the current grand jury model and provide a remedy by incorporating the continuity report functions within the same grand jury term.

# **SAN BERNARDINO** (2019-20) *County of San Bernardino Economic Development Department*

On the eve of the worst global pandemic in a century, the degree of preparedness at the San Bernardino County Economic Development Department (charged with leading both the county's business growth as well as recovery from such a potential calamity) could mean the difference between permanent economic disaster and the kind of rapid, organized, and effective recovery strategies needed to save the county's businesses. The grand jury found that the department was woefully unprepared and understaffed to handle the impending crisis.

#### SAN FRANCISCO (2020-21) Van Ness Avenue: What Lies Beneath

The grand jury uncovered a hornet's nest of city government inefficiencies and brought to the city's attention millions of dollars in budget overages on the Van Ness project. It made the front page of the local paper and received the most press of any grand jury report in San Francisco.

#### **BEST NEWS MEDIA REPORTING**

**SACRAMENTO** (2021-22) Genoa Barrow, reporter for *The Observer* (Sacramento), for her extensive, unbiased, and continuing coverage of the grand jury's investigative report *Sacramento County Board of Supervisors Abandons Responsibility for COVID-19 CARES Act Spending*. This scathing report details the apparent misappropriation of \$181 million dollars in COVID-19 CARES Act funds and examines the questionable actions of the supervisors during the worldwide pandemic.

The journalist conducted herself with integrity and provided the community with access to critical information during a worldwide pandemic. Without this journalistic candor and honesty, the story might have devolved into a "he said" "she said" quagmire with resulting dissipation of public interest. The misuse of public funds might not have come to light.

**Note**: The nomination materials are retained by the subcommittee chair. A nomination may be resubmitted in 2023 for reports and/or coverage dated 2018 or later (5-year window).
