CGJA Trainers Attend Workshop

Our new trainers demonstrated why they were selected to join our training team by presenting part of a seminar topic to the group. They all did great!



The CGJA training team is now 38 members strong as we set out to cover 54 training venues this upcoming training season, which starts on June 11 in Orange County. Our trainers hail from 23 different counties, so we are well-prepared to cover the state, presenting CGJA's best practice information to the newly sworn grand juries throughout the state.



We are looking forward to representing CGJA and to another fun and successful year training California's civil grand juries.

Ask the Trainer

Q. Are report recommendations ever shared during exit interviews?

A. No. The law limits the jury to only being able to "read and discuss the findings." All other portions of the report must remain confidential until it is released. However, jurors should ask questions about possible recommendations when they are exploring solutions to problems they have identified during their investigation, and they can also do so during the exit interview. Ask "How would you recommend solving this problem?" and ask about the cost and time needed to implement it. This will help to ensure that your recommendation will be considered reasonable and will hopefully be implemented.

Q. We're having trouble getting everyone together to vote approval on some of our reports. What is CGJA's position on voting during a remote meeting, by telephone, or by proxy?

A. All reports must be approved by a supermajority vote of the jury before they can be released. All the jurors should be present to hear a full discussion about a report before voting for or against its release. While meeting in person is preferred, jurors may participate remotely via teleconference using Zoom, Teams, or another conferencing platform, provided that the jury's procedure manual explicitly permits remote meetings. In remote meetings, all jurors must be able to hear all other participants and be able to participate in the discussion.

CGJA recommends against votes by proxy, in which a juror who plans to be absent gives their right to vote to another juror. While the Penal Code does not address proxy voting, CGJA believes all jurors who are voting on a matter must participate in the discussion and deliberations so they are fully informed about the matter before casting their vote. Because an absent juror would not be able to take part in deliberations leading up to the vote, a proxy vote should not be allowed.

Q. If we issue all our reports in a consolidated report at the end of the term instead of releasing them individually, is it okay to give the whole consolidated report to the Board of Supervisors two days before it is published, or do we have to deliver each individual report separately?

A. Individual reports should be delivered separately to each of their required respondents. Under the Penal Code, a grand jury must provide the affected agency with a copy of the grand jury report relating to that entity two working days prior to its public release. It is problematic to try to meet this requirement with consolidated reports because they ordinarily include several individual reports that list several respondents that vary from report to report. Confidentiality would be violated if a board or individual that is not a respondent to one of the individual reports within a consolidated report sees that report before it is publicly released.

On the other hand, if all individual reports within a consolidated report are addressed exclusively to a single required respondent like a county board of supervisors, then giving that respondent the consolidated report two working days before its release would meet the Penal Code requirement.

Southern California chapters/associations hold a regional online meeting

The 17 attendees were:

Los Angeles County: Carina Lister, Maureen Smith, Shirley Zaragoza, Don Gonzales, James (Jim) Bukowski, Leslie Flores, Norm Green and Sam Dodds. **Orange County**: Doug Gillen, Greg Tettemer and Lynn Bonas. **San Bernardino County**: John Bradley, Joanna Hamilton and Ron Zurek.

Ventura County: Lori Macdonald (CGJA trainer).

Other: Larry Herbst (CGJA Bylaws and Policies Review) and Sharon DeBenedetti (Sonoma County Chair).

Carina Lister (LA) reported a recent meeting with the supervising judges and court personnel with promises to give us an enhanced role. We have been meeting monthly in a restaurant near the civil grand jury office, hoping to attract current jurors. But the administration hitherto was not supportive of us. The court will not be using the CGJA training for the upcoming year.

Doug Gillen (OC) explained that the Grand Jurors' Association of Orange County (GJAOC) is an association, not a formal CGJA chapter. Their court empowers the grand jury with both criminal indictments and civil investigations. The GJAOC has strong relations with the court and has existed for 50 + years. It uses the software program, Constant Contact, to inform people of the quarterly luncheons and newsletters. The quarterly meetings feature good speakers, such as the Orange County Clerk-Recorder.

Norm Green (LA): A barrier to recruiting jurors is that the per diem stipend has not been increased for a long time. Los Angeles juror pay will be increased from \$60 to\$80 next year. What is the juror pay for other counties? Answers: Orange County - \$50. San Bernardino County - \$60. Ventura County - \$25.

Maureen Smith (LA): Do other counties' chapters help with vetting and interviewing juror applicants? Doug Gillen (OC): The GJAOC is not involved with any vetting or interviewing of applicants, per the Court's direction. John Bradley (SB): By contrast, some counties pay their CGJA chapters to interview juror applicants, thereby possibly saving some cost.

Lori Macdonald (Ventura): She gives PowerPoint presentations to the jurors in the petit jury assembly room. She has recruited in this way over 50 applicants for the grand jury.

The Southern California chapters propose to have a similar online meeting every year, including chapters or members from nearby counties.

Board Actions

04-22-25

Approved acquiring 500 lapel pins at an unbudgeted additional expense not to exceed \$600.

Amended motion: Released the funds of three Memorial Funds (\$7,511 total), of which \$3,061 goes to the to the General Fund. In addition, use \$4,450 to increase Ron Miguel & Audrey Lynberg Training Scholarship Fund to \$13,000 for T-Bill funding.

05-27-25

Approved using \$4,200 in 2024 Annual Conference (AC) donations to offset fixed expenses and approve the 2025 AC registration fee of \$101.
