MINUTES

A. Call to Order and Roll Call

The roll was taken, and the meeting began at 5:00 PM.

B. Agenda and Comments

- B-1 Agenda Approval: Board members unanimously approved the agenda.

 - D-1 **President's Report** Panetta described the serious need for help on the MCRC. He asked that directors and committee chairs make contacts and provide the names of candidates to committee chair, Lloyd. Lloyd will develop a description of the tasks and time involved.

He referred to the panel for the annual conference on grand jury awareness and recruiting. Two more panelists are needed. If you know of chapters doing interesting outreach, please let him know.

D-2 Officer Reports

Vice President (Herbst) – no report.

Treasurer (Gibbons) – no report.

Secretary (Sommer) – no report.

- D-10 Annual Conference Committee (ACC) no report.
- D-3 Legal and Legislative Resources Committee (LLRC) no report.
- D-4 **Public Relations Committee (PRC)** Jones said there is a pending press release regarding the grand jury clerks in Contra Costa County and the Rible will be helping her with the blog.
- D-5 **Membership Relations Committee (MCRC)** Lloyd brought up the previously made suggestion of providing CGJA-sponsored memberships. The plan is for two memberships to be awarded

each year to new chapter members with the goal of increasing both CGJA and chapter membership. This can be done for a minimal amount of lost revenue. She would like to bring it up at the forthcoming chapter presidents' meeting. Herbst said it was worth a try. She will do so.

Herbst asked how long members stayed on the roll after a lapse in dues. Lloyd said 60 days. She makes a particular effort to clean up the roster by July 31 for accuracy in voting eligibility.

Lloyd said two chapters were in trouble – Butte and Madera. Panetta suggested getting a local representative (Jerry Kunkel for Butte and Leanne Thomson for Madera) to show up at the training sessions being held in those counties and make a pitch for involvement.

- D-6 **Training Committee (TC)** Panetta reported that training is well underway with 3 or 4 groups every week. Jahr said she sees the evaluations and that the scores are high, and that input is very position. The trainers are good.
- D-7 **Finance Committee (FC)** Rogers said that Gibbons (Treasurer) is looking into a cell phone attachment to enable credit card payments. The committee referred its procedures to BPRC which said they were fine.
- D-8 **Nominations and Elections (NEC)** Panetta said the election is on schedule. Candidate statements and photos have been submitted.
- D-10 Awards Committee (AC) Landi said the Rolando Award committee needs one more member. There have been two nominations for the Excellence in Reporting Award (best report), but none yet for the best media coverage award. The deadline is June 30. Sommer (EIR subcommittee chair) said she expects at least one more nomination.
- D-11 **Bylaws & Policy Review Committee (BPRC)** no report, with 3 actions items to be dealt with later in the meeting.
- D-13 **Technology Committee (Tech)** Herbst reported that information and registration for the annual conference is all in place. He has been working with Caranci to see that training schedules and forms are posted. Report writing workshop information is pending. For the election, he will fix the links to the candidate statements. The election date is August 15. There was a glitch on the website that he is working to resolve by using a backup system. The website will be down for a couple of hours on Thursday.
- D-14 **Grand Jury Effectiveness Workgroup (GJE)** Finlayson said that Katie Martin has joined the committee. They are still working in getting a good database setup.

She classified the action items as falling into three groups: E-2 a grab bag of amendments, E-3 Finance Committee amendments regarding memorial funds, and E-4 pertaining to the Training Committee. She thanked committee secretary, Joann Landi, for her

competence in keeping the committee minutes. The committee will soon complete their review of committee procedures. These do not require board approval.
